Subject: Notification of Fee Structure for Ayurveda Gurukulam Affiliation – Reg.

This is to notify all concerned that the Central Sanskrit University, New Delhi, has prescribed the fee structure applicable to institutions seeking affiliation as Ayurveda Gurukulam.

The following fees shall be payable by applicants seeking affiliation as Ayurveda Gurukulam with the Central Sanskrit University. Such applicants may be a Trust, Society, University, or any other body, but shall not include Central Government institutions as mentioned in the National Commission for Indian System of Medicine (Pre-Ayurveda-Programme for Bachelor of Ayurvedic Medicine and Surgery) Regulations, 2024.

1. Fees Payable at Different Stages of Affiliation

2. Relaxation/Concession

Category	Concession	Justification
North-Eastern States / Notified Tribal Areas / Women-only Ayurveda Gurukulams/J&K State/Ladakh UT/Andaman & Nicobar Islands UT	50% of prescribed first-time affiliation fee as mentioned at S.No. 3	As a promotive and incentive measure to encourage establishment of Ayurveda Gurukulams in priority and socially relevant regions/segments.


- The above fees are payable in advance with each specific application.
- All prescribed fees are non-refundable

3. Submission of Applications:

Every applicant seeking to apply for any of the following:

- Starting a new Ayurveda Gurukulam
- Recognition / first-time affiliation
- Continuation of affiliation

shall submit a proposal on or before the last working day of the year preceding the year in which the permission is sought, in the Samarth Application Portal (https://www.sanskrit.nic.in/ayurveda_gurukulam.php) of Central Sanskrit University, New Delhi, as per the provisions of the CSU Act, 2020 and the applicable Ordinance.



4. Timeline for submission of application in various stages

- i. Application Fee for starting new Ayurveda Gurukulam – will be open throughout the year.
- ii. Processing fees submission of the application for new Ayurveda Gurukulam – will be communicated individually to the applicant.

5. Recognition and First-time Affiliation

Applicants applying for recognition of the institution (one-time) and first-time affiliation shall submit the application within the prescribed timeline and format.

6. Continuation of Affiliation

Every affiliated Ayurveda Gurukulam shall submit an application annually on or before the last working day of the year preceding the year in which continuation is sought, in the prescribed form, to the Registrar, Central Sanskrit University, New Delhi.

N.B. – Important Conditions

- a) Upon receipt of the Processing Fee, the Central Sanskrit University shall process the application for affiliation within the timeline prescribed under the applicable NCISM calendar and guidelines, as amended from time to time.
- b) The Application fees and Processing Fee paid by the applicant shall be strictly non-refundable under all circumstances, including withdrawal of application, non-recommendation, or closure of proposal.
- c) The University shall make all reasonable efforts to complete the processing, inspection and recommendation within 60 days period, subject to completeness of documents and compliance by the applicant institution.
- d) All fees prescribed under this notification are non-refundable.
- e) As an incentive/promotive measure, only 50% of the first-time affiliation fee shall be charged for proposals from:
 - 1) North-Eastern States
 - 2) Notified Tribal Areas
 - 3) Women-only Ayurveda Gurukulams
 - 4) Jammu & Kashmir State
 - 5) Ladakh UT
 - 6) Andaman & Nicobar Islands UT

(Such Ayurveda Gurukulams must be located and conducted in the respective areas.)

7. Restoration of Proposals


Applicants who had already applied for starting a new Ayurveda Gurukulam but could not obtain Essentiality / No-Objection Certificate from the respective State Government may apply for restoration of the proposal by paying an additional 10% of the prescribed processing fee.

Such proposals may be restored for five academic sessions. After six academic sessions (1 + 5 years), the proposal shall be treated as closed, and a fresh application with prescribed fee shall be required.

8. Extension of Consent for Affiliation

Applicants who have received Consent for Affiliation but could not obtain permission from NCISM within one year from the date of its issuance shall apply for extension by paying applicable fee as specified in the Fee Table under this notification.

The proposal shall be reviewed and the consent shall be extended up to the validity of the Essentiality Certificate issued by the respective State Government.



9. Closure of Proposals

Applicants who have not received permission from NCISM within six years from the date of recommendation of the proposal to the respective State Government shall have their proposal treated as closed. Such closure shall be intimated to NCISM. Further no fee will be refunded in any circumstances.

10. Transfer of Management

Affiliated Ayurveda Gurukulams may apply for transfer of management by paying the applicable fee as specified in the Fee Table under this notification. Such cases shall be processed as per the procedure notified separately.

11. Change of Name

Applications for change of name of the Ayurveda Gurukulam shall be made by paying the applicable fee as specified in the Fee Table under this notification. Such requests will be processed as per the prescribed procedure.

12. Change of Location

Affiliated Ayurveda Gurukulams may apply for change of geographical location by paying the applicable fee as specified in the Fee Table under this notification for change of location of the affiliated Ayurveda Gurukulam, as notified from time to time.


13. All applicable taxes shall be payable in addition to the prescribed fees.

14. Applicability and Revision of Fees

The fee structure prescribed under this notification shall be applicable for the Academic Year 2026-27 only and shall be subject to revision by the Central Sanskrit University from time to time, as deemed appropriate by the competent authority.


