The above reconstituted ICC shall function in accordance with the provisions of PoSH Act, 2013 and UGC (Prevention, Prohibition and redressal of Sexual Harrasment of Women Employees and Students in Higher Educational Institutions) Regulations, 2015.

The terms of reference of the Committee shall be as under:-

1. The ICC shall look into all the complaints of sexual harassment at workplace in the University Campus and devise effective measure to ensure a better environment of women at workplace. It would also welcome complaints, grievances or suggestions, if any, in this regard to ensure a congenial atmosphere in the University.
2. The Chairperson (Presiding Officer) and every member of the ICC shall hold office for a period of Two Years from the date of issue of this notification.
3. All the complaints shall be submitted through the Central E-mail ID: icc@sanskrit.ac.in.
4. The Committee shall be effective and functional at all times. It will meet once a quarter even if there is no live case.
